MEETING CALLED TO ORDER

DISCUSSION ON COUNTY PUTTING UP ANTENNA ON THE TOWER (STANDPIPE)- Kris Brice came representing the Newcastle Vol. Fire Department. He expressed the need to install the antenna on the standpipe for the safety of the community and that they would like to have a contract done on behalf of the county and the city. The City Council has agreed to get a contract made. Kris Brice requested the contract be made for \$1,000.00 per year for 20 years. **TABLED.**

DISCUSSION ON ROLL-OFFS- Dickey Baynes provided 3 bids for roll-offs. City Council looked over the bids, but Alice Winder (city secretary) made the comment that we should check with Buyboard and see if we can get anything through the Buyboard. So, Alice Winder (the city secretary) is going to do some research. **TABLED.**

DISCUSSION ON WHAT THR CITY CLERK NEEDS TO GET STARTED- Mike Peterson made the comment that the biggest obstacle was going to be finding a prosecutor. Another concern that Julia Keith had on her list was security and Mike Peterson he is considered the security as the Judge. Mike Peterson also mentioned ordering some citation packets. **TABLED**

DISCUSSION ON DOLLAR STORE UPDATE- Dickey Baynes mentioned that he was informed that the Dollar Store is in contract and that they have been asking to survey the land. The residents (Clint Hopping, Josh Bennett & Debbie Reynolds) expressed that area is residential. And they would like to keep it that way. The residents of that area expressed their concerns. The city has not been contacted about anything else, so right now that's about all we know. If we hear anything else, we will continue to let the Newcastle residents know.
