TRADD STRAWBRIDGE- Thanked the city council members for the job they are doing. He was speaking with regard to the letter he received from the city. The letter stated that his gate was obstructing Belknap Street. This letter was mailed to him because the city will need to continue the Belknap Street to provide a resident utility service. His trailer and the gate running across Belknap Street. And he wanted to know why the city cannot provide him with sewer services. This is not possible because of the location of his house and the grade in which the sewer has to flow.
